INVITATION FOR TENDERS TO ADVERTISE ON CERTAIN LAMP POLES IN THE TOWNS OF ALIWAL NORTH AND JAMESTOWN.

Tenders are invited in terms of Council's Procurement Policy to advertise on certain lamp poles in Barkly Street, Grey Street, Young Street, Somerset Street, and Daniel Pienaar Avenue in Aliwal North and Voortrekker Street in Jamestown.

The poles in each of the streets on which signage will be allowed are clearly marked with the number of the pole on a yellow square.

The successful tender will lease the poles for a term of 3 years with an option to lease for another term of 3 years.

The following conditions will apply:

- a) Tender amount must be inclusive of VAT
- b) A tax clearance certificate from SARS must be furnished.
- c) Maletswai Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid.

- d) Bids which are late, incomplete, unsigned will not be accepted.
- e) Bids offered per fax or e-mail will not be accepted.
- f) The use of tippex or erasure on tender documents is not allowed.
- g) No bids will be accepted from persons in the employ of the State.
- h) Bids may only be submitted on original documents issued by the municipality.
- i) Copy of CK1 and ID copies of members must be furnished.
- j) Municipal accounts must be attached.
- k) All bids received shall be evaluated in terms of the Preferential Procurement Policy Framework Act, 2000 and the Preferential Procurement Regulations, 2011 promulgated in Government Gazette No. 34350 dated 8/06/2011. The 80/20 preference points system will be used and awarded as follows: Price – 80, B-BBEE – 20. A status level verification certificate must be attached.
